<b>Date of the event</b>	October 3-4, 2018
<b>Brief summary of the content of the workshop</b>	<p>First, we were introduced and then we discussed instruments that describe language teacher competences. We focused on these in relation to the website called Resources Platform which is designed to help teacher educators, teachers, managers etc. to find out more about such instruments and to choose those of interest to them.</p> <p>Second, we were introduced and then we discussed the first draft of an overview of teacher competences for languages in education. We closely explored each of the five dimensions and discussed its contents. Then, we discussed whether it would be useful to create, in the near future, a teacher competence framework for language education</p>
<b>What did you find particularly useful?</b>	I found both parts of the workshop useful – learning about the platform as well as the five dimensions.
<b>How will you use what you learnt / developed in the event in your professional context?</b>	I will definitely refer to the platform when relevant. As for the overview of the competences, I will use it as a point of reference in the development of a national framework of language teacher competences that is currently in progress.
<b>How will you further contribute to the project?</b>	I am not currently aware of any further possible forms of contribution.

V říjnu 2018 se v Grazu uskutečnil workshop pod názvem Směrem ke Společnému evropskému rámci pro učitele jazyků představující aktivity projektu se stejným názvem a zabývající se kroky, které by mohly být základem případného rámce. V průběhu prvních dvou let projektu došlo týmem projektu k analýze a kompilaci různých dokumentů (okolo 40) poskytující rámce a popisy kvality pedagogické práce. Výsledkem jsou webové stránky, kde je možno vygenerovat dokumenty podle různých kritérií. Zároveň jsou u každého dokumentu poskytnuty základní informace pro rychlou navigaci. Součástí stránek jsou i příklady z praxe a využití jednotlivých dokumentů v praxi (<https://www.ecml.at/ECML-Programme/Programme2016-2019/TowardsaCommonEuropeanFrameworkofReferenceforLanguageTeachers/Overview/tabid/3021/language/en-GB/Default.aspx>). Při zpracování a analýze jednotlivých dokumentů se tým projektu pokusil nadefinovat tzv. "dimensions" nebo-li oblasti, které by se staly základem společného rámce. V době workshopu v Grazu, nebylo jasné, jestli rámec vznikne a nebo ne a v jaké případně formě. Oblasti, které byly identifikovány v pracovní verzi přehledu kompetencí učitelů jazyků jsou: profesní hodnoty a principy (Professional values and principles), předměty (The subjects), pedagogika (Pedagogy), spolupráce s zainteresovanými osobami (Cooperation with other stakeholders), vzdělávání a celoživotní rozvoj učitelů (The teacher's education and lifelong professional development).
