Brief summary of the content of the workshop	Getting acquainted with the goals of the VITbox project, the team behind it, and the progress made so far. This text should be provided in your national language(s) to be used for dissemination (on websites, for journals etc.).</p> <p>CEFR Companion Volume Implementation Toolbox (VITbox) projekti eesmärk on luua tasuta materjalide kogum/ andmebaas, kust leidub keeleõpetaja koolitamisega seotud isikutele usaldusväärseid ja oma vajadustele kohandatavaid materjale. Andmebaasi lisatakse nii põhimõisteid selgitavaid esitlusi kui ka eri tasemetele mõeldud praktilisi keeleõppėülesandeid, mida tundides kasutada saab.</p> <p>Esmajärjekorras on projekt suunatud õpetajakoolituse läbiviijatele ja õppekavade koostamisega seotud isikutele toetamaks Euroopa keeleõppé raamdokumendi täiendatud käsitluste laiemat levikut keeleõppes, aga kindlasti on see väga kasulik ka tegevõpetajatele, sest raamdokumendi sõsarväljaande peamised mõisted on selgitatud lihtsalt ja lühidalt ning seetõttu on niigi ajapuuduses õpetajatel kergem end tähtsamate uuendustega kurssi viia. Praktiliste ülesannete juures on väljavõtted seotud sõsarväljaande tasemekirjeldustest, seega kasutajal on koheselt näha, millist keelekasutuse valdkonda vastava ülesandega arendatakse ja kuidas see haakub sõsarväljaandega. Projekti läbivijatel on plaanis andmebaasi lisada ka soovitusi ja juhiseid hindamise osas, kuid põhiröhk on tegevuspõhisel (action-based) lähenemisel keeleõppele ja keeleõppé paremaks sidumiseks nüüdisaja õppijate vajadustega, et sealäbi õpetamisprotsessi tõhustada ja õppijate motivatsiooni ning rahulolu veelgi tõsta. Ülesanded ja esitlused pannakse üles esialgu inglise ja prantsuse keeltes, aga ajapikkus on plaan laiendada materjalivalikut ka teiste keeltega.</p>
