Cjelovita kurikularna reforma sa sobom je donijela i uvođenje novih kurikuluma međupredmetnih tema (Građanski odgoj, Uporaba IKT-a, Održivi razvoj, osobni i socijalni razvoj, Poduzetništvo, Učiti kako učiti i Zdravlje). Svi ovi dokumenti unutar razrada ishoda uključuju mnoge od transverzalnih kompetencija koje su prepoznate na ovoj radionici. Uz navedene kurikulume važno je istaknuti i Okvir nacionalnog standarda kvalifikacija za učitelje u osnovnim i srednjim školama, objavljen 2016 te Europski okvir digitalnih kompetencija za obrazovatelje (DigCompEdu) iz 2017. godine (prevela i prilagodila za hrvatsko govorno područje Hrvatska akademска i istraživačка mreža – CARNET) kojima su definirani ishodi čije ostvarivanje se očekuje kod učitelja i nastavnika. Ovi ishodi također uključuju i mnoge kompetencije prepoznate na ovoj radionici. Iz svega navedenog vidljivo je da su u Republici Hrvatskoj transverzalne kompetencije prepoznate i da je stvoren kvalitetan okvir za njihovu implementaciju. Kao glavni ciljevi koji proizlaze iz zaključaka ove radionice su: izrada smjernica za učitelje i nastavnike stranih jezika te smjernica za ustanove koje educiraju nove učitelje i nastavnike stranih jezika. Nadalje potrebno je podići razinu svijesti o mnogobrojnim kompetencijama (transverzalnim kompetencijama) koje su potrebne današnjim odgojno-obrazovnim radnicima. Agencija za odgoj i obrazovanje aktivno će pratiti razvoj i aktivnosti na *Think Tank* projektu kako bi hrvatskim učiteljima i nastavnicima stranih jezika osigurali pristup najnovijim trendovima i razmišljanjima i što kvalitetnije mogućnosti edukacije i napredovanja.
