Projekto komandos nariai – islandė Sigurborg Jonsdottir, Maltais atstovas Daniel Xerri ir bulgarė Nadezhda Doychinova supažindino su projekto eigoje atliktais darbais. Ypatingo dėmesio sulaukė kandietė Wendy Carr, pristačiusi savo šalies patirtį kalbų mokymo/mokymosi klausimais.

Europos šiuolaikinų kalbų centro vykdomosios direktoriės pavaduotoja Susanna Slivensky (<http://www.ecml.at/>) pakvietė dalyvauti naujojoje veiksmų programe 2016-2019 metais (<http://call.ecml.at/>), supažindino su Europos šiuolaikinių kalbų centro įgyvendinamais projektais.
