

The main purpose of the workshop is to encourage increased collaboration between language teachers associations while at the same time disseminating ECML projects and curricular innovation to ensure that they reach practitioners on the ground. During the course of the workshop participants explored different ECML projects and their implementation. At the same time the workshop created a space for participants to share experiences and practices around professional development and collaboration with partners.

The ECML LACS project (Language Associations and Collaborative Support) aims to increase awareness of ECML projects and to encourage language professionals to engage with them. The project recognises the role of language teachers' associations and other networks at regional and national levels in facilitating the dissemination and adaptation of new methodologies and pedagogies in language teaching and learning. At the same time the LACS project aims to support and empower language practitioners by providing opportunities to share ideas and practices. The main outcome of the project is an online publication *Learning from each other : a handbook for language teacher associations* which includes information for language associations on issues such as recruitment of new members, organisation of training events, communicating with members and representing members amongst others. A Directory of associations and other language organisations is being developed which aims to encourage teachers and associations to seek and foster collaboration with colleagues across Europe.
