<b>Brief summary of the content of the workshop</b>	Through plenary session and group work, professionals involved in research, language and other skill policy making, as well as workforce development professionals, teacher trainers working in the field of adult second language learning, vocational instructors, providers of apprenticeships & pre-employment programmes, teachers of the majority language involved in or planning workplace provision, employer and trade union representatives gained deeper insight on policies and practices that help to promote a European learning network to support the professional development of language teaching professionals in an emerging field: learning of the majority language by migrant and ethnic workers in the workplace. Although the project targets adults in employment its outcomes and outputs will be relevant also for language development of (young) adults seeking employment and for teachers of vocational courses. Through correspondence, network meetings and workshops the project will bring interested professionals into communication to share research, policy and practice across Europe.
