Brief summary of the content of the event	The event focused on a number of language-related topics not only at the level of the Council of Europe (CoE) and European Commission language policies, but also at the level of initial teacher education and continuing professional development. There was also opportunity to deepen awareness on the ECML thematic areas and resources. Overall, the event enabled participants to reflect on the complexities of the linguistic needs of learners today and how education systems can help language educators provide language-friendly learning environments.
What did you find particularly useful?	The opportunity to share, interact with and learn from experts and colleagues working across several education fields about CoE recommendations and the role of languages in education in a pluri-literacy perspective; language education in the context of plurality and multilingual classrooms; trends, shifts and priorities in education policy; curriculum and language teaching practice.
How will you use what you learnt / developed in the event in your own professional context?	I plan to develop a collaborative project with partner countries (Greece, Poland and Slovakia) to support teachers working in CLIL and L2 settings at upper primary and lower secondary level (ISCED 2). This will involve setting up partnerships with higher education experts and schools to deliver a workshop.
How do you plan to share what you have learned/discovered with others in your country? 2. A Direção-Geral da Educação representou Portugal na *Inspiring Innovation in European Language Teacher Education — Summer Academy for teacher educators working in the field of languages*, promovida pelo Centro Europeu de Línguas Vivas, do Conselho da Europa (European centre for Modern Languages — ECML / Council of Europe — CoE), que decorreu em Graz, Áustria, entre 24 e 28 de junho de 2024.

Reunindo representantes de 25 países europeus, os quais colaboram nos respetivos sistemas educativos, nas áreas da educação, formação inicial e contínua, ensino superior e investigação, esta iniciativa visou aprimorar a capacitação de formadores de professores de línguas estrangeiras, de modo a que estes possam, por sua vez, apoiar os seus pares na resposta às atuais necessidades linguísticas dos alunos.

Dinamizada por especialistas internacionais, os conteúdos abordados centraram-se nas tendências atuais na aprendizagem, ensino e avaliação de línguas, nomeadamente:

- O ensino de línguas num contexto de pluralidade: mudanças fundamentais nas políticas educativas, currículo e prática letiva
- A recomendação do Conselho da Europa sobre a importância de educação plurilingue e intercultural para a cultura democrática
- Aspetos-chave dos referenciais Volume Complementar do QECR¹ e do FREPA²
- Como o ECML/CoE pode encontrar-se ao serviço dos diversos contextos

Este evento constituiu-se como uma extraordinária oportunidade de aprendizagem, partilha e reflexão entre profissionais falantes de diversas línguas que, nesta ocasião, falaram uma língua única: a do reconhecimento de que a aprendizagem de línguas é, cada vez mais, determinante num contexto de pluralidade, não somente na manutenção dos valores europeus e na promoção da cultura democrática, como também no acesso a uma educação de qualidade e ao sucesso educativo. Pelo impacto decisivo que esta iniciativa pode ter nas ações de política educativa de línguas nos diversos sistemas educativos, recomenda-se uma participação ativa em edições futuras da mesma por parte de profissionais ligados ao ensino de línguas.
